



Welcome to the latest edition of the Safeguarding Newsletter. The pandemic has continued to impact dramatically on our lives during the course of the last year and it is very much hoped that we are moving towards an easing of restrictions. Church House remains closed and the Safeguarding Team are continuing to work remotely, offering support to parishes and dealing with ongoing safeguarding matters. An update in relation to training and development, Past Cases Review 2 (PCR2) in addition to contact details for the safeguarding team and out-of-hours support is provided in this newsletter.

Training and development

It has not been possible to deliver face to face safeguarding training during the current pandemic. In view of this, Basic (C0) and Foundation (C1) training have been made available online on the [diocese's safeguarding web page](#). All of those with safeguarding responsibilities working with children and vulnerable adults are required to undertake C1 training every three years.



The Safeguarding Team are able to deliver leadership training via Zoom to groups of a maximum of 12 people. This is prioritised for those with key safeguarding responsibilities and a role in shaping the culture of the parish. Training for those with PTO and Reader Emeritus is on hold whilst the National Safeguarding Team develop a specific module for these roles. Safeguarding Policy and guidance

All parishes work in line with the [Parish Safeguarding Handbook](#) introduced by the National Safeguarding Team (NST) in 2018 (this replaced Manchester Diocese's Safeguarding Policy, 2016). A Cathedral Safeguarding Handbook has now been approved.

Past Cases Review 2

Further to our last update, progress is continuing on the Past Cases Review 2 within the Diocese of Manchester. Our Independent Reviewer, Suzanne Cottrell, has now completed her review of all known safeguarding concerns within the Diocese and has moved on to undertake her review of clergy personal files.



Once the review of clergy files has been completed, it is anticipated that the Reviewer will move on to undertake the review of the Readers' files, before concluding the review by considering any other relevant church officer files held in Church House.

The Reviewer is required to report her findings directly to the Independent Chair of the Diocesan Safeguarding Panel, Kathy Batt, as well as the Bishop of Manchester. She is expected to make her report by the summer of 2021.

Bishop David would like to thank all who have supported the implementation of this national project within the Diocese of Manchester.
